Ex-Judge Wireman indicted on burglary, other counts

Former Lafayette City Court Judge Lewis T. Wireman today was indicted, arrested and charged with 12 counts of conspiracy, receiving stolen goods and burglarizing homes.

All of the counts refer to the period during which he sat on the bench including five charges that he personally broke into Lafavette area homes stealing personal items, including antique coins.

Wireman was arrested in a parking lot in front of West Lafavette City Hall at 12:30 p.m. today as he left the Indiana Supreme Court Disciplinary Commission hearing which had adjourned for the day. He faces similar charges before the commission which is attempting to disbar

ONE OF THE homes he is charged with conspiring to burglarize is that of Maurice Callahan, a fellow Lafavette Democratic city official-city engineer.

Wireman was immediately taken to the Indiana State Police post where he was fingerprinted and booked. Bond was set at \$35,000 by Superior Court 1 Judge Robert Mun-

Wireman, after his arrest, de-

He was indicted by the grand jury twice. One of the indictments charges him with three counts of first-degree burglary. That indictment is not being publicly released at this time.

THE OTHER indictment names nine charges against him:

-Two counts of first-degree burglary at the home of Alvin Morehouse. 1820 Ravinia Rd., W.L., on Feb. 20 and May 11, 1974.

-- Conspiring to break into the home of Morehouse with David Banton and Richard Dean Smith.

-- Theft by "knowingly" obtaining control over a revolver and three rifles stolen from the home of William Osborn, 1318 South St., on Feb. 20, 1974. Value of the items was listed at \$300.

-Theft by "knowingly" obtaining control over \$150 stolen from the home of Kenneth L. McCord. of Lori-Lee Mobile HOme Court. The incident is alleged to have occurred Feb. 25, 1974.

-Conspiring with Smith and David and Paul Banton to break into the home of George Gourko, Mar Jan Mobile Home Court on March 8.

-Theft by obtaining control over ' rare coins valued at \$10,000 stolen from the Gourko residence. Gourko owns a downtown coin store.

-- Conspiring with the Bantons and Smith to break into Callahan's home, 1401 N. 27th St., on March 15.

-Theft by "knowingly" obtaining control of Lincoln pennies valued at \$700 stolen from the Morehouse home. The incident allegedly took place May 15, 1974.

DAVID RANTON and Smith both have testified before the grand jury investigating corruption here, giving evidence against Wireman.

Wireman's bid for re-election was smashed last November by allegations that he was involved in criminal activity. He was defeated by over 5,000 votes by Republican Raymond Gollmitzer in one of the most one-sided city races in recent memo-

Dick Weatherford is the brother of Mike Weatherford, a central figure in street violence that occurred in Lafavette in the fall of 1974.

On Halloween night that year Mike Weatherford's wrecker truck was blown up and Kenneth Terry was later murdered - both still unsolved crimes.

Dick Weatherford . 34, has been charged with third-degree, arson at Alton Boxboard the night after the murder and wrecker truck explosion

He is being held on \$25,000 bond. Damage to the Boxboard plant that night was listed at \$57,000.

DICK WEATHERFORD previously has been convicted for second-degree burglary, theft from an interstate shipment and conspiracy
