## 19 more indicted by grand jury

Judge Robert Munro of Superior Court 1 this afternoon was writing warrants for the arrest of 19 more people indicted by the grand jury today on 29 different counts. It was believed several police officers were among them. It was also believed there would be one more indictment late today before the jury ends its session, now in the first day of the eighth week.

In addition to the 19 people indicted-this morning for the first time, the grand jury indicted two people for the second time and filed amendments to three previous indictments.

The JURY now has indicted 52 people. By late this afternoon that number was expected to be 53.

The action came at 9:40 a.m. today as the jury prepared to hear testimony from six witnesses, subpoenaed after it was thought testimony had been concluded.

Four of them were police officers: Patrolman Jerry Metzger of the Lafayette Department; Patrolman Richard Wolf and Harold Roberts of the Tippecanoe County Department and Lt. Oscar Gates of the Indiana State Police.

Others testifying were William Buckles and Laura Shepard.

The indictments today were expected to include accused gamblers.
State Police Saturday confiscated gambling material from the Lahr

Hotel House of Billiards, on 5th St., and from the home of Richard Miller, 1303 S. 28th St.

The material was collected after search warrants were issued by Munro.

Today was the fourth time the jury has gone to court to issue indictments and the scene has been the same each time.

The jurors were seated in the jury box with the foreman closest to

"I understand you have some indictments," Munro said.

"Yes sir, that's correct," said the foreman, and handed him a stack of manil folders.

"I also understand you have more

work to do," Munro said.
"Yes we do," said the forman,
and the jury was excused.

But it was believed there was little work remaining for the jury to

After hearing the witnesses it was believed they would meet in a short executive session to consider an additional indictment.

They were scheduled to adjourn, at which time a report would be issued stating what the jurors had done during their lengthy session.

Names of those who have been indicted are not released until arrests are made. The delay in the arrests following indictments is caused by the length of time it takes to prepare warrants, set bonds and type out court docket sheets.

Wolf testified this morning for 10 minutes. He was followed by Metzger, who was also in the jury room for 10 minutes, Buckles, who testified for 15 minutes, Gates, who testified for 20 minutes, and Mrs. Shepard.

Gates worked on the special state police investigation here.
